No. SRO A-43/2019.— In exercise of the powers conferred by sub-section (1) of Section 180 of the Tamil Nadu Co-operative Societies Acts, 1983 (Tamil Nadu Act 30 of 1983), the Governor of Tamil Nadu hereby makes the following amendments to "The Restructured Peraringnar Anna Co-operative Milk Producers Welfare Fund Rules, 2010".

AMENDMENTS

In the said Rule,- in rule 15, -

(a) in sub-rule (d), -

in clause (i) for the expression Rs.1.75 lakh (Rupees One lakh seventy five thousand only)", the expression Rs.2.50 lakh (Rupees Two lakh fifty thousand only)", shall be substituted:

(b) in sub-rule (e), -

(i) in clause (i), for the expression "Rs.10,000/- (Rupees Ten thousand only)" the expression "Rs.25,000/- (Rupees Twenty five thousand only)", shall be substituted;

(ii) in clause (ii), for the expression, "Rs.10,000/- (Rupees Ten thousand only)", occurring in two places, the expression "Rs.30,000/- (Rupees Thirty thousand only)", shall be substituted;

(iii) after clause (ii) the following shall be added, namely,-

(iii) to provide assistance of a sum of Rs.5000/- (Rupees Five thousand only) as funeral expenses to the family of deceased milk pouring member.
