#### Amendment to the Indian Administrative Service (Pay) Rules, 2016.

*[G.O. Ms. No. 65, Public (Special-A), 12th January 2023, Margazhi 28, Subakiruthu, Thiruvalluvar Aandu-2053.]*

No. SRO A-5/2023.—The following Notification of the Government of India Ministry of Personnel, Public Grievances and Pensions Department of Personnel and Training, New Delhi, dated 30th December, 2022 is republished:-

**G.S.R. 930(E)**.-In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Services Act, 1951 (61 of 1951), the Central Government, in consultation with the Government of Tamil Nadu, hereby makes the following rules further to amend the Indian Administrative Service (Pay) Rules, 2016, namely:-

1. (1) These rules may be called the Indian Administrative Service (Pay) Fourth Amendment Rules, 2022.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Indian Administrative Service (Pay) Rules, 2016, in the Schedule II-,  
(a) In Part A relating to Posts carrying pay above the Senior Scale of Pay of the Indian Administrative Service under the State Governments, in the table, for the entry "**Tamil Nadu**" occurring in the first column and corresponding entries in the second column, the following shall be substituted namely:-
