Amendment to the Special Rules for the post of Assistant Director of Statistics in the Department of Economics and Statistics for the Tamil Nadu Statistics Service.

No. SRO B-12/2024.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Statistics Service (Section 26A in Volume-II of the Tamil Nadu Services Manual, 2016).

AMENDMENT

In the said Special Rules, in rule 4, in the TABLE, against the entry "Assistant Director of Statistics" in column (1) and the corresponding entry "Direct recruitment" in column (2) thereof, for item 2 including the proviso there under in column (3), the following item shall be substituted, namely:-

- "2. (i) Must hold a First Class Degree in Statistics or Mathematics or Economics or Applied Economics or Business Economics with not less than 60% marks or equivalent Cumulative Grade Point Average (CGPA); or
- (ii) Master's degree in Statistics or Mathematics or Economics or Applied Economics or Applied Statistics or Applied Mathematics or Business Economics or Operations Research or Mathematical Economics or Econometrics."
