The Government of Tamil Nadu, having been satisfied that the lands specified in the Schedule below have to be acquired for industrial purpose of setting up Petroleum Product Storage Terminal of Hindustan Petroleum Corporation Limited at Sivadi Village and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled or managed by Government.
