ISSUE OF POSTAL BALLOT TO ELECTORS ABOVE THE AGE OF 80 YEARS AND
ELECTORS WITH PHYSICAL DISABILITY

The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated.17th September, 2020 is published:-

In pursuance of the provisions of clause (c) of Section-60 of the Representation of the People Act, 1951, the Election Commission hereby specifies that the electors above the age of 80 years and electors with physical disability as already marked/flagged in the data base of the electoral rolls of the State/Union Territory and who request for voting by postal ballot paper, would be a class of persons to give vote by postal ballot in the general elections or bye-elections in the State/Union Territory concerned, to be notified under Section 30 of Representation of the People, 1951, as per the provisions in Part-III A of the Conduct of Elections Rules, 1961, as amended *vide* Ministry of Law & Justice, Govt. of India, Notification SO No. 3786(E), dated 22nd October, 2019, and the directions and guidelines issued by the Election Commission, until further orders.

ISSUE OF POSTAL BALLOT TO ELECTORS IN QUARANTINE DUE TO COVID-19

The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated 17th September, 2020 is published:

In pursuance of the provisions of clause (c) of Section-60 of the Representation of the People Act, 1951, the Election Commission hereby specifies that the Covid-19 suspect or affected persons, certified by competent authority, who request for voting by postal ballot paper, would be a class of persons to give vote by postal ballot in the forthcoming general election to the Legislative assembly of Bihar and bye-elections in several states, to be notified under Section 30 of Representation of the People, 1951, as per the provisions in Part-III A of the Conduct of Elections Rules, 1961, as amended *vide* Ministry of Law & Justice, Govt. of India, Notification SO No. 3786(E), dated 22nd October, 2019, and the directions and guidelines issued by the Election Commission.
