AMENDMENTS TO THE TAMIL NADU URBAN LOCAL BODIES RULES, 2023

[G.O. Ms. No. 60, Municipal Administration and Water Supply (Elec.), 16th March 2024,

In exercise of the powers conferred by section 198 of the Tamil Nadu Urban Local Bodies Act, 1998 (Tamil Nadu Act 9 of 1999), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Urban Local Bodies Rules, 2023:-

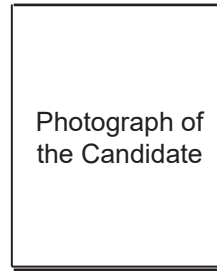
2. The amendments hereby made shall be deemed to have come into force on the 13th April 2023.

AMENDMENTS.

In the said Rules,—

- (1) in rule 25, for the expression "role", the expression "roll" shall be substituted;
- (2) in rule 66, in sub-rule (7), for the expression "rule 63", the expression "rule 62" shall be substituted;
- (3) in rule 97, in sub-rule (2), in clause (a), for the expression "clause (b) of sub-rule (4) of rule 60", the expression "sub-rule (5) of rule 60" shall be substituted;
- (4) in rule 120, for the expressions "vote", "name" and "candidate", the expressions "vote or votes", "name or names" and "candidate or candidates" shall, respectively, be substituted;
- (5) in rule 122, for the expression "record the vote", the expression "record the vote or votes" shall be substituted;
- (6) in Chapter III,—

(i) in Form 3 and Form 4, in the right side top corner, the following box shall be inserted, namely:—



(ii) in Form 8, Form 9 and Form 10, for the expression "Returning Officer" wherever it occurs, the expression "Returning Officer/Assistant Returning Officer" shall be substituted;

(iii) in Form 12 and Form 25, after the expression "(To be handed over to the polling agent for production at the polling station.)" at the end, the following expression shall be added, namely:—

"Relevant provisions in section 13 of the Act.— Every officer, clerk, agent or other person performing any duty in connection with the recording or counting of votes at an election who, except for some purpose authorised by law, communicates to any person, any information showing directly or indirectly for which candidate any voter has voted, and every person who by any improper means, procures any such information, shall be punished with imprisonment which may extend to six months or with fine, or with both.";

(iv) for Form 26, the following form shall be substituted, namely:—

(v) in Form 28, for the expression "rule 97", the expression "rule 74" shall be substituted;

(7) in rule 227,—

(a) in TABLE 1, under the heading "1.TOWN PANCHAYAT GENERAL WING", in Sl.No.1,—

(i) in column (3), against the expression "Driver" in column (2) thereof, after the expression "Record Clerk", the expression "Sanitary Supervisor" shall be inserted;

(ii) in column (4), against the entry "(2) By promotion from among the holders of the post of Record Clerk, Office Assistant, Cleanliness Worker and Skilled Assistant" in column (3) thereof as so amended, after the expression "Sanitary Supervisor or", the expression "Office Assistant or" shall be inserted;

(b) in TABLE II, under the heading "2. TOWN PANCHAYAT ENGINEERING WING",—

(i) in Sl.No.2, in column (3), against the entry "Junior Engineer" in column (2) thereof, for the expression "form", the expression "from" shall be substituted;

(ii) in Sl.No.3, for the entries in column (4), against the entries "(2) By promotion from among the holders of the post of Work Inspector and Skilled Assistant in the ratio 5:1." in column (3) and "Overseer" in column (2) thereof, the following entries shall be substituted, namely:-

"(1) Must possess a Diploma in Civil or Mechanical or Electrical Engineering or any other qualification considered equivalent thereto awarded by any recognized University or Institution.

(2) Must have rendered service as Work Inspector for a period of not less than five years or as Skilled Assistant for a period of not less than seven years, as the case may be.";

(8) in rule 270, in sub-rule (3), in clause (a), in items (v) and (vi), for the expression "Three", the expression "Two", shall be substituted;

(9) in rule 320, for the entries "(2) Every application made under sub-rule (1) shall be accompanied with the receipt of payment of the application fee specified under rule 332 through demand draft or any other mode of payment as indicated by the municipality", the entries "(3) Every application made under sub-rule (1) shall be accompanied with the receipt for payment of the application fee specified under rule 332 through demand draft or any other mode of payment as indicated by the municipality" shall be substituted."
