WHEREAS, a written notice of the intention to make a motion expressing want of confidence in Tmt.Vennila.K, Chairperson, Thittakudi Municipal Council, Cuddalore District, signed by twenty three members, out of the sanctioned strength of twenty four members of the Council, together with a copy of the motion proposed to be made and a written statement of charges against the said Chairperson have been delivered to the Commissioner, Thittakudi Municipal Council, Cuddalore District in person by two members as required under sub-section (2) of section 51 of the Tamil Nadu Urban Local Bodies Act, 1998 (Tamil Nadu Act 9 of 1999);

AND WHEREAS, a motion expressing want of confidence in Tmt.Vennila.K, Chairperson, Thittakudi Municipal Council, Cuddalore District had been carried with a support of twenty three members out of the sanctioned strength of twenty four members of the said Municipal Council in the meeting convened by the Commissioner, Thittakudi Municipal Council, Cuddalore District on the 22nd October 2025 after following the procedures specified in the said section 51 and the copy of the minutes of the meeting together with a copy of the motion and the result of the voting thereon, on the termination of the meeting have been forwarded by the Commissioner under sub-section (11) of the said section 51 to Government;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (12) of section 51 of the Tamil Nadu Urban Local Bodies Act, 1998 (Tamil Nadu Act, 9 of 1999), the Governor of Tamil Nadu, hereby removes Tmt.Vennila.K, Chairperson, Thittakudi Municipal Council, Cuddalore District from the Office of the Chairperson of the said Thittakudi Municipal Council with immediate effect.
