WHEREAS, a written notice of the intention to make a motion expressing want of confidence in Tmt. B. Farida Nawab, Chairperson, Krishnagiri Municipal Council, Krishnagiri District, signed by twenty three members, out of the sanctioned strength of thirty three members of the Council, together with a copy of the motion proposed to be made and a written statement of charges against the said Chairperson have been delivered to the Commissioner, Krishnagiri Municipal Council, Krishnagiri District in person, as required under sub-section (2) of section 51 of the Tamil Nadu Urban Local Bodies Act, 1998 (Tamil Nadu Act 9 of 1999);

AND WHEREAS, a motion expressing want of confidence in Tmt. B. Farida Nawab, Chairperson, Krishnagiri Municipal Council, Krishnagiri District had been carried with a support of twenty seven members out of the sanctioned strength of thirty three members of the said Municipal Council in the meeting convened by the Commissioner, Krishnagiri Municipal Council, Krishnagiri District on the 10th November 2025 after following the procedures specified in the said section 51 and the copy of the minutes of the meeting together with a copy of the motion and the result of the voting thereon, on the termination of the meeting have been forwarded by the Commissioner under sub-section (11) of the said section 51 to the Government;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (12) of section 51 of the Tamil Nadu Urban Local Bodies Act, 1998 (Tamil Nadu Act 9 of 1999), the Governor of Tamil Nadu, hereby removes Tmt. B. Farida Nawab, Chairperson, Krishnagiri Municipal Council, Krishnagiri District from the Office of the Chairperson of Krishnagiri Municipal Council with immediate effect.
