DRAFT AMENDMENT TO THE TAMIL NADU MOTOR VEHICLES RULES, 1989.

The following draft amendment to the Tamil Nadu Motor Vehicles Rules, 1989, which is proposed to be made in exercise of the powers conferred by sections 65 and 211 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), is hereby published for information of all persons likely to be affected thereby, as required by sub-section (1) of section 212 of the said Act.

2. Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of fourteen days from the date of publication of this Notification in the Extraordinary issue of *Tamil Nadu Government Gazette* and that any objection or suggestion, which may be received from any person with respect thereto, before the expiry of the aforesaid period, will be considered by the Government of Tamil Nadu.

3. Objection or suggestion, if any, should be addressed in duplicate to the Additional Chief Secretary to Government, Home Department, Chennai-9.

DRAFT AMENDMENT

In the said Rules, in rule 132, in the Table, for serial number 1 in column (1) and the corresponding entries in columns (2), (3) and (4) thereof, the following serial number and the entries shall, respectively, be substituted, namely:-

“1.(a) For allotment of advance registration number by the Government for any class of vehicle:-

(i)	for first four series, that is, current series and next three series	80,000/-	91(2)
(ii)	for 5th series to 8th series	1,20,000/-	91(2)
(iii)	for 9th series and 10th Series	2,00,000/-	91(2)
(iv)	for 11th series and 12th Series	4,00,000/-	91(2)
(v)	for any vehicles from 13th series and 14th series	8,00,000/-	91(2)

(b) For allotment of advance registration number by the Registering Authority for two wheelers and three wheelers (including battery operated vehicles):-

(i)	for Vehicles whose value not exceeding Rs.50,000/- (Rupees fifty thousand only)	2,000/-	91(3)
(ii)	for Vehicles whose value exceeds Rs.50,000/- (Rupees fifty thousand only) but not exceeding Rs.1 lakh. (Rupees one lakh only)	6,000/-	91(3)
(iii)	for Vehicles whose value exceeds Rs.1 lakh (Rupees one lakh only) but not exceeding Rs.2 lakhs. (Rupees two lakhs only)	10,000/-	91(3)
(iv)	for Vehicles whose value exceeds Rs.2 lakhs (Rupees two lakhs only) but not exceeding Rs.5 lakhs. (Rupees five lakhs only)	20,000/-	91(3)
(v)	for Vehicles whose value exceeds Rs.5 lakhs (Rupees five lakhs only) but not exceeding Rs.10 lakhs. (Rupees ten lakhs only)	30,000/-	91(3)
(vi)	for Vehicles whose value exceeds Rs.10 lakhs (Rupees ten lakhs only) but not exceeding Rs.20 lakhs (Rupees twenty lakhs only).	40,000/-	91(3)
(vii)	for Vehicles whose value exceeds Rs.20 lakhs (Rupees twenty lakhs only) but not exceeding Rs.30 lakhs (Rupees thirty lakhs only).	50,000/-	91(3)
(viii)	for Vehicles whose value exceeding Rs.30 lakhs (Rupees thirty lakhs only)	1,00,000/-	91(3)

(c) For allotment of advance registration number by the Registering Authority for all imported cars and other vehicles:-

(i)	for vehicles whose value is upto Rs.4,00,000/- (Rupees four lakhs only)	20,000/-	91(3)
(ii)	for vehicles whose value exceeds Rs. 4,00,000/- (Rupees four lakhs only) and upto Rs.10,00,000/- (Rupees ten lakhs only)	32,000/-	91(3)
(iii)	for vehicles whose value exceeds Rs.10,00,000/- (Rupees ten lakhs only) and upto Rs.20,00,000/- (Rupees twenty lakhs only)	40,000/-	91(3)
(iv)	for vehicles whose value exceeds Rs.20,00,000/- (Rupees twenty lakhs only) and upto Rs.50,00,000/- (Rupees fifty lakhs only)	75,000/-	91(3)
(v)	for vehicles whose value exceeds Rs.50,00,000/- (Rupees fifty lakhs only)	1,50,000/-	91(3)
