AMENDMENTS TO THE TAMIL NADU LIQUOR (LICENCE AND PERMIT) RULES, 1981.

In exercise of the powers conferred by sections 17-B and clause (iii) of sub-section (2-A) of section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu, hereby makes the following amendments to the Tamil Nadu Liquor (Licence and Permit) Rules, 1981:-

2. The amendments hereby made shall be deemed to have come into force on and from 1st day of April, 2026.

AMENDMENTS.

In the said Rules,-

(1) in rule 17, in sub-rule (b), in clause II,-

(a) for the expression “an annual privilege fee of Rs.15,00,000/- (Rupees fifteen lakhs only) for Chennai City and Rs. 10,00,000/- (Rupees ten lakhs only) for the other areas, a licence fee of Rs.30,000/- (Rupees thirty thousand only) and an application fee of Rs.10,000/- (Rupees ten thousand only)” the expression “an annual privilege fee, a licence fee and an application fee as per the table below” shall be substituted;

(b) The following (TABLE) shall be inserted before the first proviso :-
