No.II(2)/HWMP/257/2020.—The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below have to be acquired for Highways purpose for forming Road Over Bridge in Salem District, Mettur Taluk, M.Kalipatty Village at Km 40/8 of Sankakiri-Mecheri road (via) Edappadi (SH 220) in lieu of existing LC No.18 at Railway Km 23/800-900 between Omalur and Mecheri Railway Stations and it has already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by the Divisional Engineer (Highways) Projects, Salem District after considering the cause shown by the owner (or) other person having interest on such lands as the case may be do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).
