**Notification under the Tamil Nadu Brewery Rules, 1983**

[G.O. Ms. No. 32, Home, Prohibition and Excise (III), 21st September 2020, புரட்டாசி 5, சார்வரி, திருவள்ளூர் ஆண்டு-2051.]

No. SRO A-35/2020.—In exercise of the powers conferred by rule 41 of the Tamil Nadu Brewery Rules, 1983, the Governor of Tamil Nadu hereby exempts Thiruvallur United Breweries Limited, Aranvoyal Village, Thiruvallur District from the operation of sub-rule (2) of rule 10 of the said rules in so far as it relates to the maximum time limit specified therein so as to enable the said company to install the New Pasteurizer in Bottling Line-2 and to dispose of the existing old one subject to the condition that the said works shall be completed on or before the 31st December 2020.

2. This Notification shall be deemed to have come into force with effect on and from the 2nd May 2020.

**Amendment to the Tamil Nadu Micro and Small Enterprises Facilitation Council Rules, 2017**

No. SRO A-36/2020.—In exercise of the powers conferred by sub-section (1) of Section 30 of the Micro, Small and Medium Enterprises Development Act, 2006 (Central Act 27 of 2006), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Micro and Small Enterprises Facilitation Council Rules, 2017, namely:-

**AMENDMENT**

In the said Rules, in rule 7, in sub-rule (i), for the expression “the Udyog Aadhar Memorandum (UAM) number,”, the expression “Udyam Registration number or Udyog Aadhar Memorandum (UAM) number (which shall be valid for a period up to the 31st March 2021)” shall be substituted.
