[G.O.Ms.No. 56, Home (Police VI), 4th February 2021, *தை 22 சார்வரி, திருவள்ளூர் ஆண்டு-2052.*]

No. SRO B-9/2021.— In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and Sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the Proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Police Subordinate Service (Section 34 in Volume III of the Tamil Nadu Services Manual 2016):-

2. The amendments hereby made shall be deemed to have come into force on and from the 29th June, 2020.

AMENDMENTS

In the said Special Rules, in Annexure II, in the tabular columns, in column (2),-

(1) against the entry "Category 2 Sub-Inspectors of Police" in column (1) thereof, after the fifth proviso, the following proviso shall be inserted, namely:-

"Provided also that for appointment of a candidate who is a transgender, the upper age limit shall be 33 years";-

(2) against the entry "Category 2A Sub-Inspectors of Police (Finger Print)" in column (1) thereof, after the fifth proviso, the following proviso shall be inserted, namely: -

"Provided also that for appointment of a candidate who is a transgender, the upper age limit shall be 33 years.";

(3) against the entry "Category 5 Sub-Inspectors of Police (Armed Reserve) (Men and Women)" in column (1) thereof, after the fifth proviso, the following proviso shall be inserted, namely:-

"Provided also that for appointment of a candidate who is a transgender, the upper age limit shall be 33 years.";

(4) against the entry "Category 8 Constables (Men and Women) (other than Band Constables office of the Director General of Police) and Constables (Armed Reserve)" in column (1) thereof, after the fifth proviso, the following proviso shall be inserted, namely:-

"Provided also that for appointment of a candidate who is a transgender, the upper age limit shall be 29 years.".

Amendments to the Special Rules for Tamil Nadu Police Subordinate Services.

No. SRO B-10/2021.— In exercise of the powers conferred by Sections 8 and 10 of the Tamil Nadu District Police Act, 1859 (Central Act XXIV of 1859) and sections 9 and 11 of the Chennai City Police Act, 1888 (Tamil Nadu Act III of 1888) read with the Proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Police Subordinate Service (Section 34 in Volume III of the Tamil Nadu Services Manual 2016):-

2. The amendments shall be deemed to have come into force on the 1st March 2019.

AMENDMENTS

In the said Special Rules,—

(1) in rule 25, in sub-rule (a)-,

(i) for the first proviso, the following proviso shall be substituted, namely:-

"Provided that in the case of Sub Inspectors of Police (Taluk) as well as Sub-Inspectors of Police (Finger Print) recruited direct, the seniority in their respective Categories shall be fixed on the basis of the marks obtained by them in the final examination conducted by the Tamil Nadu Police Academy or the Police Training College"

(ii) after the seventh proviso, the following proviso shall be added, namely:-

"Provided also that the seniority of the Sub-Inspectors of Police (Finger Print) directly recruited from the departmental quota shall be fixed above the direct recruits selected from open quota in the same year."

(2) in Annexure-II, in the tabular column, under class 1 in column (3) against the entry "Category 2A Sub-Inspectors Police (Finger Print)" in column (1) and the corresponding entries in column (2) thereof, in item (3),-

(i) in sub-item (ii), for the expression 'only three times', the expression "only two times" shall be substituted;

(ii) for sub-item (iii), the following sub-item shall be substituted, namely:-

"(iii) In respect of departmental quota candidates, out of those who are qualified in the written test only two times of the number of notified vacancies in each of the categories such as open competition, Backward Classes, Backward Classes (Muslims), Most Backward Classes, Scheduled Castes including Arunthathiyar, Schedule Tribes and Women shall be permitted to *viva-voce*, based on the marks obtained in the written test:.

No. SRO B-11/2021.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu General Subordinate Service (Section 13 in Volume III of the Tamil Nadu Services Manual 2016)

2. The amendments hereby made shall be deemed to have come into force on and from the 31st August 2012.

AMENDMENTS

In the said Special Rules,

(1) in Part-I, the expression "Class XXVIII A- Junior Architect in the Chief Architect's Section of the Office of the Chief Engineer (General), Public Works Department' shall be omitted.

(2) in Part-II, the expression "CLASS XXVIII A-JUNIOR ARCHITECT IN THE CHIEF ARCHITECT'S SECTION OF THE OFFICE OF THE CHIEF ENGINEER (GENERAL), PUBLIC WORKS DEPARTMENT" and the rules made thereunder shall be omitted.

Re-issue of Special Rules for the Tamil Nadu Architect Service

No. SRO B-12/2021.— In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, and in supersession of the Special Rules for the Tamil Nadu Architect Service published with the Public Works Department Notification No.SRO-B-503/86 at pages 672-677 of Part III-Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 31st December 1986, the Governor of Tamil Nadu hereby makes the following Special Rules for the Tamil Nadu Architect Service (Section 41 in Volume II of the Tamil Nadu Services Manual 2016).

2. The rules hereby made shall be deemed to have come into force on and from the 31st August 2012.

RULES

1. Constitution.-The Service shall consist of the following categories namely:-

Category 1	:	Cheif Architect
Category 2	:	Joint Chief Architect
Category 3	:	Senior Architect
Category 4	:	Assistant Architect
Category 5	:	Junior Architect

2. Appointment.- (a) Appointment to the categories specified in column (2) of the Table below shall be made by the method specified in the corresponding entries in column (3) thereof

THE TABLE.

<i>Sl.No.</i>	<i>Category</i>	<i>Method of appointment</i>
(1)	(2)	(3)
(1)	Chief Architect	By promotion from among the holders of the post of Joint Chief Architect.
(2)	Joint Chief Architect	By promotion from among the holders of the post of Senior Architect.
(3)	Senior Architect	By promotion from among the holders of the post of Assistant Architect.
(4)	Assistant Architect	By promotion from among the holders of the post of Junior Architect.
(5)	Junior Architect	By direct recruitment.

(b) Promotions in the service shall be made on grounds of merit and ability, seniority being considered only where merit and ability are approximately equal.

3. Appointing Authority.- The appointing authority for the post of Junior Architect shall be the Chief Architect.

4. Qualifications:- (a) Age.-No. person shall be eligible for appointment to the post of Junior Architect by direct recruitment, if he has completed or will complete thirty years of age on the first day of July of the year in which the selection for appointment is made.

(b) Other Qualifications.-No person shall be eligible for appointment to the categories specified in column (2) of the Table below, by the method specified in column (3), unless he possesses the qualifications specified in the corresponding entries in column (4) thereof:-

THE TABLE.

(1)	Chief Architect	Promotion	Must have a minimum period of one year of left over service before retirement at the time of actual promotion Provided that when a junior is promoted as Chief Architect under these rules, the senior shall be appointed as Special Chief Architect with a Specific assignment.
(2)	Joint Chief Architect	Promotion	Must have served as Senior Architect for a period of not less than one year.
(3)	Senior Architect	Promotion	Must have served as Assistant Architect for a period of not less than five years.
(4)	Assistant Architect	Promotion	Must have served as Junior Architect for a period of not less than five years.
(5)	Junior Architect	Direct Recruitment	Must possess a degree in Architecture of any University or Institution recognised by the University Grants Commission and should be a registered member of the Council of Architecture.

5. Reservation of appointment.-The rule relating to reservation of appointments as provided in rule 22 of the General Rules for the Tamil Nadu State and Subordinate Services shall apply for appointment to the post of Junior Architect by direct recruitment;

Provided that on and from the 14th September 2016, Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) shall be applicable of selection for appointment to the said post in the matter of reservation.

6. Probation.- Every person appointed to the post of Junior Architect by direct recruitment from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

7. Tests.- Every person appointed as Junior Architect by direct recruitment shall, within the period of his probation pass the Tamil Nadu Government Office Manual Test and the Account Test for Subordinate Officers, Part-I. He shall not be liable to be discharged for failure to pass that said tests within the period of probation, but his probation shall be extended up to a maximum period of five years and his second and subsequent increments shall be stopped without cumulative effect till he passes the said tests. if he does not pass the said tests even within the maximum period of five years, his probation shall be terminated.

8. Preparation of annual list of approved candidates.- The crucial date on which a person should be qualified for selection for appointment to the categories by promotion, shall be the 1st September of every year.

9. Postings and transfers.-The Chief Architect shall be the competent authority to issue order of postings and transfers of Assistant Architects and Junior Architects.

10. Savings.-Nothing contained in these rules shall adversely affect the service of any person holding the post on the date of publication of these rules in the *Tamil Nadu Government Gazette*.

(i) for the entry "3, Electrician, Grade II" in the column (1) and the corresponding entries in column (3) thereof, the following entries shall be substituted, namely:-
