Notice is hereby given that an election by direct polling is to be held in the University premises for electing one member to the Governing Council of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, as per clause (a) of sub-section (4) of Section 21 of The Tamil Nadu Dr. M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987) by the Senate from among its member to fill the arising residual vacancy. The term of membership in the Governing Council will be for a period upto 08.02.2027 from the date of publication of the results of the election or the date on which he/she ceases to hold the post of Senate member of this University whichever is earlier.

2. Forms of Nomination papers to be obtained from the Registrar(FAC), who is the Returning Officer from **20.08.2025 (Wednesday) to 01.09.2025 (Monday)** between **11.00 hrs. and 13.00 hrs. on** all working days.

Nomination papers may be enclosed in an envelope addressed to the Registrar(FAC) / Returning Officer and superscribed "**Nomination for election to the Governing Council**" as indicated below, and sent by Registered Post (Acknowledgement Due), so as to be received by the Registrar(FAC) / Returning Officer not later than 14.00 hrs. on 01.09.2025 or delivered to the Returning Officer during office hours in person or by his proposer or by messenger under acknowledgement within the date and hour mentioned above.

(a) The Elections will be held in accordance with rules and procedures stipulated for the conduct of Election to the University authorities as per the Statutes of this University.

(b) Nominations / declarations should be made in the prescribed form which may be obtained from the Registrar (Returning Officer) / downloaded from this University website.

Nomination papers shall be enclosed in an envelope superscribing the above elections (each election separately) and sent by Registered Post (with Acknowledgment due), so as to be received by the Returning Officer / Registrar, Manonmaniam Sundaranar University, Abishekapatti, Tirunelveli, within the date and hour fixed or delivered either in person or by messenger to the Returning Officer within the last date and hour fixed. Nomination papers that are not enclosed in an envelope, superscribed and sent by Registered , Post or are not delivered in person or by messenger as required above shall be declared invalid.

(c) An elector shall be eligible to subscribe either as proposer or as seconder in nomination papers, only as many times as there are vacancies but not more.
