Under the heading "Residential use zone" the expression S.F.No.: 66/1A & 66/2A1, shall be added before the S.F. No: 122/1

Under the heading "Agricultural use zone" the expression S.F. Nos: 66 shall be deleted and the expression S.F. No: 66 Pt (Except 66/1A & 66/2A1) shall be substituted.
