No. 17755/2025/TCP-9 Dt: 16.09.2025 proposes to make the following individual draft variation for Deletion. of Proposed Bye Pass 60 M wide A-A Scheme Road part - S.No.54/2 & 55/4B in Thottapattu Village / Panchayat – Cuddalore Panchayat Union – Cuddalore Taluk – Cuddalore District, to the Approved Thottapattu Detailed Development Plan No.3 of Cuddalore Local Planning Authority approved by Director of Town and Country Planning, Proceeding in Roc. Conferment of Magisterial Powers on Certain Revenue Officials

No.VI(1)/567/2025.

No.191/2025.—In exercise of the powers conferred under Section 11 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Act No.46 of 2023), the High Court hereby appoints the following **(i) 5 Deputy Tahsildars in Ranipet District, (ii) 2 Deputy Tahsildars in Tenkasi District and (iii) 8 Deputy Tahsildars in Tirunelveli District** as Special Judicial Magistrates, to undergo Magisterial Training for a period of **120 days**, from the date of assumption of charge and confers upon them the ordinary powers conferable under this Code on a Judicial Magistrate to try such cases which were earlier triable and dealt with by an erstwhile Judicial Second Class Magistrate.

Under the Heading III - under the Sub Heading III(c) - **Special and Hazardous** INDUSTRIAL USE ZONE, Survey Numbers 137/1, 137/2A, 138/1A, 138/1B, 138/2A,138/2B, 138/2C & 138/2D shall be added.
