No. SRO A-32/2025.—The following draft amendment to the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) (Tamil Nadu) Rules, 1983, which is proposed to be made in exercise of the powers conferred under sub-section (1) of Section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (Central Act No.30 of 1979) is hereby published for information of all persons likely to be affected thereby, as required under the said section of the said Act.

2. Notice is hereby given that the following draft amendment will be taken into consideration on or after the expiry of the period of one month from the date of publication of this Notification in the *Tamil Nadu Government Gazette* and that any objection or suggestion which may be received from any person with respect thereto, before the expiry of the aforesaid period will be considered by the Government of Tamil Nadu. Objection or suggestion if any, should be addressed to the Secretary to Government, Labour Welfare and Skill Development Department, Secretariat, Chennai-600 009 through the Commissioner of Labour, Chennai-600 006 and the Director of Industrial Safety and Health, Chennai-600 032.

DRAFT AMENDMENT

- (1) in rule 51, in sub-rule (1), the expression, "in Form XV" shall be omitted;
- (2) in rule 52, in sub-rule (2), sub-clauses (c) and (d) shall be omitted;
- (3) in rule 56, in sub-rule (2), in the proviso, after clause (d), the following clauses shall be added namely:-

"or (e) a combined annual return in Form No.22 as required in clause (2) of rule 100 of the Tamil Nadu Factories Rules, 1950 is furnished; or

(f) a combined annual return in Form No.XXV under Schedule XIII as required in rule 242 of the Tamil Nadu Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2006 is furnished.";

Amendments to the Tamil Nadu Private Schools (Regulation) Rules, 2023.

No. SRO A-33/2025.—In exercise of the powers conferred by Section 57 of the Tamil Nadu Private Schools (Regulation) Act, 2018 (Tamil Nadu Act 35 of 2019), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Private Schools (Regulation) Rules, 2023.

AMENDMENTS

In the said Rules, in rule 9 -

1. for sub-rule (2), the following sub-rule shall be substituted, namely:

"(2) The application shall be made within a period of three months prior to the date of expiry of the period of certificate of recognition or renewal of certificate of recognition, as the case may be.";

2. after sub-rule (5), the following sub-rule shall be inserted, namely:-

"(6) Schools applying for renewal of certificate of recognition shall submit a copy of the fee determination order that is currently valid and in force, issued by the Tamil Nadu Private Schools Fee Determination Committee under the Tamil Nadu Schools (Regulation of Collection of Fee) Act, 2009 (Tamil Nadu Act 22 Of 2009).".
