The following order of the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training, North Block, New Delhi, dated: 9th October, 2025 is republished:-

Order:

Whereas, Smt.R.Gajalakshmi, IAS., (SCS:TN:2009) was appointed in Indian Administration Service vide Notification No. 14015/21/2013-AIS(I)-B dated 24.12.2013 and her date of birth was recorded as 01.02.1966.

And whereas, after careful examination of records and in compliance of Court Orders, Government of Tamil Nadu had altered the date of birth of Smt. R. Gajalakshmi, IAS., (SCS:TN:2009) as 02.02.1967 instead of 01.02.1966.

And whereas, sub-rule (3) of rule 16-A of the All India Services (Death-cum-Retirement Benefits) Rules, 1958 provides that in respect of a person appointed to IAS by promotion from State Civil Service, the date of birth as recorded in the service book or other similar official document maintained by the concerned State Government shall be accepted by the Central Government as the date of birth of such person;

Now, therefore, in exercise of the powers conferred under rule 16-A of the All India Services (Death-cum-Retirement Benefits) Rules, 1958, Central Government hereby orders that the date of birth of Smt. R. Gajalakshmi, IAS., (SCS:TN:2009) be altered in her service records from 01.02.1966 to 02.02.1967.
