No.I/PUSP/37/2025.—The following order of the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, Kartavya Bhawan-03, New Delhi, dated 28th November 2025 is republished:-

Whereas, Dr. R. Selvaraj IAS, (SCS: TN: 2005) was appointed to Indian Administrative Service, *vide* notification No. 14015/21/2009-AIS(I)-B dated 02.08.2010 and his date of birth was recorded as 25.05.1969.

And whereas, after careful examination of records and reports from the authorities, Government of Tamil Nadu *vide* G.O (Ms.) No. 265 dated 22.05.2025 had altered the date of birth of Dr. R. Selvaraj, IAS, (SCS:TN:2005) from 25.05.1969 to 17.05.1970.

And whereas, sub-rule (3) of rule 16-A of the All India Services (Death-*cum*-Retirement Benefits) Rules, 1958

provides that in respect of a person appointed to IAS by promotion from State Civil Service, the date of birth as recorded in the service book or other similar official document maintained by the concerned State Government shall be accepted by the Central Government as the date of birth of such person.

Now, therefore, in exercise of the powers conferred under rule 16-A of the All India Services (Death-*cum*-Retirement Benefits) Rules, 1958, the Central Government hereby orders that the date of birth of Dr. R. Selvaraj, IAS., (SCS:TN:2005) be altered in his service records from 25.05.1969 to 17.05.1970.
