2. From the Director General of Police/Head of Police Force, Chennai letter Rc. No.2906658/Medal 2(2)/2025, dated 22.10.2025.

Order:- No. 592, Home (SC), dated 26th November 2025.

Based on the Announcement of the Hon'ble Chief Minister of Tamil Nadu on the floor of the Tamil Nadu Legislative Assembly on 29.04.2025, a medal was instituted in the name of the "Tamil Nadu Chief Minister's Medal for Excellence in Intelligence (20 Nos.) and Excellence in Special Operations" (10 Nos.) in the order 1st read above.

2. The Director General of Police/Head of Police Force (i/c), Chennai, in his letter 2nd read above has requested to increase the upper limit of sanction of the said medals in respect of Tamil Nadu Chief Minister's Medal for Excellence in Intelligence from 20 to 30 and Excellence in Special Operation from 10 to 20 as detailed below:-

- a) Additional Director General of Police, Intelligence will be the Nodal Officer and propose suitable nomination for 10 numbers in Operations & 20 numbers in Intelligence; and
- b) Additional Director General of Police, Law & Order will be the Nodal Officer and propose suitable nomination from the Districts and Cities (including Chennai), other units for 10 numbers in Operations and for 10 numbers in Intelligence.

3. The above request of the Director General of Police/Head of Police Force (i/c), Chennai was examined carefully and independently and it was decided to accept it.

4. Accordingly, the following amendment is issued to the Government order 1st read above:-

AMENDMENT

(i) In Rule-(x), the words-

"20 Medals for Excellence in Intelligence and 10 Medals for Excellence in Special Operation" may be read as-

"30 Medals for Excellence in Intelligence" and 20 Medals for Excellence in Special Operation"

(ii) In Rule-(xviii), the words-

a) "5 numbers in Operation and 5 numbers in Intelligence" may be read as-

"10 numbers in Operation and 10 numbers in Intelligence"

b) "5 numbers in Operation and 15 numbers in Intelligence" may be read as-

"10 numbers in Operation and 20 numbers in Intelligence".
