In exercise of the powers conferred by Article 229 of the Constitution of India and all other powers connected thereto, Hon'ble the Chief Justice, High Court, Madras is hereby pleased to make the following Amendments to the High Court's Notification No. SRO C-4/2018 at Page Nos. 12-15 of Part III - Section 2 of the *Tamil Nadu Government Gazette* (Issue No.7) dated 14.02.2018.

AMENDMENTS

1. In the said Notification, in page no.12, under the Heading "RULE" after paragraph 3, the following paragraph "Consequent to the recommendation of the Official Committee, the Orders issued by the Government in G.O.(Ms).No.90, Finance (Pay Cell) Department, dated 26.02.2021, creating 5 more cells for each level in the Pay Matrix contained in Schedule-I and III in G.O.Ms.No.303, Finance (Pay Cell) Department, dated 11.10.2017, shall be made applicable to the members of the High Court Service (including Madurai Bench of Madras High Court, Madurai; Office of the Official Assignee, High Court, Madras; Tamil Nadu State Judicial Academy, Chennai and its Regional Centres at Coimbatore and Madurai; Tamil Nadu Mediation and Conciliation Centre, High Court, Madras and its Madurai Bench; and Arbitration Centre, High Court, Madras)" shall be inserted.
