In the Government Order first read above, the Government have ad-interimly attached the property of the partners of Tvl.Meenakshi Finance, Purasawakkam, Chennai for their default in return of deposits made by the depositors after maturity under section 3 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44

of 1997) and transferred the control over the said property to the Competent Authority and District Revenue Officer,

In the Order second read above, the Hon'ble Special Court under TNPID Act, 1997, Chennai, on the petition filed by the Inspector of Police, Economic Offences Wing – II, Chennai under section 5 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997) against Tvl.Meenakshi Finance, S.Padmaja, M.Sasidaran and 10 others for their default in return of deposits made by the depositors after maturity, has acquitted all the accused on the grounds among others that:-

- (a) the accused of the Financial Establishment collected Rs.34,19,250/- from 35 depositors. Out of 35 depositors, 25 depositors' amount have been settled before laying charge sheet. After framing the charge sheet they have settled the amount to the depositors to the tune of Rs.8,71,000/-. The balance to be settled only Rs.6,000/-.
- (b) when the case was posted for judgement one of the complainant i.e P.W.10 Ravichandran has filed a memo stating that he received Rs.6,000/- from A.6 Vijayakumar. In the memo he has mentioned that the above said amount has been received from A.6 without any compulsion from anybody. It shows that entire amount has been settled in this case. Under the circumstances, charge against the accused in respect of Rs.6,000/- does not arise.

3. In the Order third read above, the Hon'ble Special Court under TNPID Act 1997, Chennai on the application filed by Tmt. S.Padmaja, W/o. (Late) M.Sasidaran under section 7(6) of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997) to raise the property attached in the Government Order first read above, has allowed the petition and raised the order of ad-interim attachment on the grounds that already the offence was compounded under section 5A of the said Act and the counter affidavit filed by the Competent Authority and District Revenue Officer do not have any objection in raising the order of ad-interim attachment.

4. In the Order fourth read above, the Hon'ble Chief Metropolitan Magistrate Court, Egmore, Chennai on the petition filed by the Inspector of Police, Economic Offences Wing – II, Chennai under sections 406 and 420 Indian Penal Code against Thiru.Sasidaran, S/o. Madavan Pillai and under section 406 read with section 109 of Indian Penal Code against Tmt. Padmaja, W/o. Sasidaran, partners of Tvl.Meenakshi Finance, has ordered that the charges against A1 has abated since he is dead and acquitted A2.

5. In the letter fifth read above, the Competent Authority / District Revenue Officer, Chennai District has sent a proposal and requested the Government to raise the order of ad-interim attachment made in the Government Order first read above, consequent to the orders of the Hon'ble Special Court under TNPID Act, 1997, Chennai and the Hon'ble Chief Metropolitan Magistrate Court, Egmore, Chennai read above.

6. In the representation sixth read above, Tmt.S.Padmaja, W/o. (Late) M.Sasidaran has requested the Government to raise their property from attachment referring to the judgements in the orders second and fourth read above.

7. In the letter seventh read above, the Additional Director General of Police, Economic Offences Wing, Chennai has offered no objection to cancel the attachment made in the Government Order first read above stating that all the accused of the said defaulted financial institution are acquitted from the cases registered in Chennai EOW-II Cr.Nos.14/2005 and 15/2003 on settling of entire defaulted amount to the depositors.

8. The Government after careful examination, have decided to accept the proposal of the Competent Authority/District Revenue Officer, Chennai based on the report of the Additional Director General of Police, Economic Offences Wing and also the orders passed by the Hon'ble Special Court for TNPID Act, Chennai and the Chief Metropolitan Magistrate Court, Egmore, Chennai. Accordingly, in exercise of the powers conferred by section 3 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act
