In exercise of the powers of conferred by section 61 of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments (Protection and Maintenance) Act, 2018 (Tamil Nadu Act 44 of 2018) the Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board by publishing **the following Scheme framed by the Vanniyakula Kshatriya Public Charitable Trusts and Endowments board** vide its resolution dated 23.02.2026 passed in the 34th Board meeting held on 23.02.2026 **for Araneri Govindu Naicker Trust Chennai**, which was created by Thiru Araneri Govindu Naicker vide. his Will dated 25.3.1846 bequeathed and dedicated all his valuable properties at Chennai and Kancheepuram to promote education and educational charities, to grant pension to the descendants of the testator Govindu Naicker and to do religious charities. Bequeathing all his properties to the above trust.

Scheme for Araneri Govindu Naicker Trust

The SCHEME is hereby framed by the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board (hereinafter referred to as the Board) in pursuance of the power conferred under section 61 of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments (Protection and Maintenance) Act, 2018 (hereinafter referred to as the Act) for the management and the administration of the Araneri Govindu Naicker Trust which was created by Thiru Araneri Govindu Naicker who belonged to Vanniyakula Kshatriya Community. Thiru Araneri Govindu Naicker vide. his Will dated 25.3.1846 bequeathed and dedicated all his valuable properties at Chennai and Kancheepuram to promote education and educational charities, to grant pension to the descendants of the testator Govindu Naicker and to do religious charities.

The scheme for the Management and the administration of **Araneri Govindu Naicker Trust** with movable and immovable properties more fully described in the schedule hereunder, is hereby approved in the 34th Board meeting held on 23.02.2026.

There shall be a Trust in the name and style of Araneri Govindu Naicker Trust. The address of the Registered Office of the Trust, unless otherwise changed by the Board of Trustees, shall, for the present, be at bearing No. 1/1(1), Mayor Ramanathan Salai, Egmore, Chennai- 600 008.

The scheme shall come into force from this date onwards to achieve the following objects:

Main Objects of the Scheme:

a) The Trust shall be for the welfare and upliftment of students and persons belonging to Vanniyakula Kshatriya Community and the general public.

b) To establish, run and maintain the Institute of Management Educational Institutions like schools, colleges of Arts and Science, Polytechnics, Colleges of Engineering and Technology, Medicine, Bio technology, Law and post graduate institutions in the various fields of education in Engineering, Medicine, Commerce, Arts and Science, all other fields etc., either in the name of Araneri Govindu Naicker for the welfare and upliftment of the students belonging to Vanniyakula Kshatriya Community and downtrodden people.

c) To establish institutions for Research and Development in the various fields of education.

d) To establish training centres, Model production centres and Industrial Units to facilitate practical training to students of polytechnic or Engineering or Technical College and provide them adequate training in the fields of production, finance, HR, marketing and entrepreneurship so as to create self employment among Vanniyar youths and Hindu Community people.

e) To train the students belonging to Vanniyakula Kshatriya community for competitive exams like NEET, JEE, UPSC, TNPSC, TNUSRB, SSC, banking exams, etc.

f) To grant educational allowances, scholarships, stipends, books and render financial aid to the needy students belonging to Vanniyakula Kshatriya community.

g) To establish a center for employment generation and guidance.

- h) To establish any fund to further the interest of the Trust.
- i) To construct Kalayana Mandapam/Commercial complex, etc. in the name of Araneri Govindu Naicker Trust to raise the income of the trust so as to make it self-reliant.
- j) To provide hostel facilities to the deserving Vanniyar and downtrodden students and to provide financial assistance to the fit and deserving students.
- k) To acquire by purchase, gift or otherwise, any lands, house-sites and buildings, to erect, build and construct or aid and assist in the erection, construction of houses, buildings for educational institutions and colleges, libraries, staff quarters, hostels and/or other type of buildings of construction whatsoever and to maintain or run them and if necessary to alter, demolish or reconstruct them or any portion or portions thereof as may from time to time found necessary or expedient.
- l) To accept donations, endowments, gifts, grants-in-aid and subscriptions to achieve the object of the Trust on such terms.
- m) To purchase, acquire, hold and manage, all or any movable and immovable properties acquired or purchased by the Trust.
- n) To collect such rent or charges or other money from occupants of hostels, buildings or rooms, staff quarters, shops or commercial complexes otherwise as may be deemed necessary at the rates to be fixed by the Trust from time to time.
- o) To collect, manage and disburse the funds raised or to be raised for all or any of the objects of the Trust.
- p) To receive grants, donation, assistance, aid in cash or kind from government /semi government authority or agency or form any other Trust, corporate body, institution individuals etc.
- q) The excess of Income over the Expenditure should be expended with the prior sanction of the Board by the Trustees in the Establishment of new educational institutions, any scheme for providing livelihood and upliftment of persons belonging to Vanniyakula Kshatriya Community.
- r) Specific religious offerings to be performed in the name of Arnary Govindu Naicker at Chennai and Kancheepuram. Special religious offerings with flower worship in Shri Ranganathar Swamy at Kancheepuram and in Shri Devarja Perumal Swamy at Kancheepuram, temples at Poonamallee and Thirumazhasai as specified in the will.
- s) To pay pension to the descendents of the Aranery Govindu Naicker who is in need of financial assistance.
- t) The income shall be applied only towards the objects and purposes as aforesaid.
- u) And generally to do and cause to be done all such lawful things as are in accordance with the spirit and principles or the objects of the Trust or which are conducive to the attainment and pursuit of the aims and objects of the Trust for the benefit of the Vanniyakula Kshatriya community at large and general public from time to time.

THE BOARD OF TRUSTEES

CLAUSE – (1) CONSTITUTION OF THE BOARD OF TRUSTEES:

- i. There shall be five trustees and among them one shall be the President, one shall be the Secretary of the Trust and one shall be the Treasurer of the Trust elected by the Board of Trustees. Among 5 Trustees one shall be a woman.
- ii. Among the five Trustees, one shall be either a retired Hon'ble High court Judge or retired IAS officer or District Judge or Directors, Additional Directors/ Additional Registers of Central/ State Governments / Additional Commissioners or equivalent cadre senior officials.
- iii. One shall be an Engineer.
- iv. One shall be from the profession of lawyer
- v. One shall be a teaching faculty or Doctor or Auditor or Financial Expert.
- vi. One shall be an Eminent person having good reputation who has served the cause of the Vanniyakula Kshatriya Community.

CLAUSE – (2) QUALIFICATION:-

- i. No person shall be elected or appointed to hold office as Trustee unless:-
- ii. He or she is an Indian. He or she is a Hindu by religion and has faith in any Hindu mode of worship and religious practice.
- iii. He or she must belongs to Vanniyakula Kshatriya Community.
- iv. He or she should have obtained a minimum educational qualification of SSLC from a School recognized by the Central / State Government.
- v. He or she should have completed 30 years of age and not more than 75 years of age.

CLAUSE – (3) DISQUALIFICATION: -

No person shall be elected or appointed or nominated to hold office as Trustee or to continue to hold Office.

- i. If he or she becomes a person of unsound mind.
 - ii. If he or she is blind, deaf or mute.
 - iii. If he or she is suffering from any serious mental disorder, leprosy or any contagious disease.
 - iv. If he or she is an undischarged insolvent.
 - v. If he or she is convicted of any criminal offence involving moral turpitude.
 - vi. If he or she is removed from any other Trust /Charity/Charitable Society for any irregularity in the past.
 - vii. If he or she is incapable of holding such a post by virtue of an order of court.
 - viii. If he or she holds any position in any political party.
 - ix. If he or she is an atheist or not a believer of Hindu mythology or worship.
2. No one who is a member of the staff of the Trust or associated with or having any interest in the trust or institution, or to whom a contract has been awarded by the Trust or any close family member of such persons or to whom a contract has been awarded by the Trust, shall be eligible to be elected or nominated as a Trustee.

CLAUSE – (4) SELECTION OF BOARD OF TRUSTEES;

- i. A Committee consisting of three persons shall be formed by the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board. One among them shall be the Secretary of the Committee.
- ii. The Secretary of the Committee shall invite applications for appointment of Trustees by making suitable advertisement in one leading Tamil Daily.
- iii. The committee shall fix the last date for receipt of applications.
- iv. The committee shall fix a non-refundable fee of Rs. 500/- payable by each of the applicant who wishes to apply.
- v. On receipt of the applications, the committee shall scrutinize the applications and process the same and place the application of those who have the necessary qualification as indicated in clause (2) before the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board at the earliest for selection and appointment of the Board of Trustees by the Board.
- vi. The Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board shall be the appointing authority of the Board of trustees and shall select and appoint the trustees by virtue of the power conferred under section 27 (2) (vi) of the Act 44 of 2018.
- vii. The future vacancies arising in the Board of Trustees caused by death, resignation, retirement, disqualification shall be filled up from the rest of the qualified applicants who had already applied if available and willing. Otherwise, such vacancies will be filled up as per clause 4 of the scheme by inviting applications for appointment of Trustees by making suitable advertisement in one leading Tamil Daily for the remaining period of his/their tenure.

viii. The above exercise should be repeated on completion of the tenure of Trustees and to induct new Trustees.

CLAUSE – (5) TENURE OF OFFICE: -

Every Trustee selected and appointed under the scheme shall hold office for a period of three years. The persons selected and appointed as Trustees shall be eligible to be re-selected or re-appointed for another period of three years. But, no Trustee shall serve more than two periods.

CLAUSE (6) SECURITY DEPOSIT:

The person appointed as Trustee shall furnish a security deposit of Rs. 5000/- (Rupees Five Thousand) only by way of demand draft in the name of the Trust which shall be refundable to the person concerned on their completion of tenure of office without interest.

CLAUSE (7) FUTURE APPOINTMENT OF TRUSTEES:

The Secretary or the Board of Trustees shall approach the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board, 3 months before the completion of 3 years tenure of Trustees, for fresh appointment of Trustees as per the above terms of the Trust.

CLAUSE (8) REPORTING OF DEVIANT BEHAVIOUR :

Any deviant behavior of any Trustee shall immediately be brought to the knowledge of Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board for appropriate action as decided by the Board.

CLAUSE (9) REMOVAL OF TRUSTEES:

The Trustees shall be liable for acts of malfeasance, misfeasance and non-feasance. A Trustee is also liable to be removed if found to be unfit to continue as a Trustee as a result of any activity prejudicial to the interest of the Trust by the board as provided in section 58 of the Act 44/2018.

Clause (10) VESTING OF THE TRUST PROPERTY:-

a. The Trust properties morefully described in the schedule hereunder and the properties to be purchased by the trust out of trust's fund in future or otherwise acquired shall be vested with the Trustees and shall be administered and managed by them subject to and in conformity with the provisions of the Act 44 of 2018 and the scheme.

b. The Board of Trustees shall prepare a list of properties, both movable and immovable, shares, outstanding stocks, etc, belonging to the Trust.

CLAUSE (11) CONVENING OF BOARD MEETING

a) The Board of Trustees shall meet and transact business at least once in a month and if necessary, more often. The quorum for the conduct of the business shall be not less than three Trustees. The resolution of the Board shall be decided by the majority of the Board of Trustees present and voting. The meeting of the Board shall also be convened by the Secretary with the direction of the President or on the requisition received from a Trustee or trustees, after giving due notice of not less than one week to the Trustees.

b) The agenda shall be prepared by the Secretary in consultation with the President and with his/her approval. The notice shall specify the date, time and venue of the meeting.

c) In the case of the absence of the Secretary or on his refusal to convene the meeting, the President may convene the meeting.

d) On requisition by at least two or more Trustees, an emergency meeting shall be convened by the Secretary or by the President in the absence of or refusal by the Secretary.

e) In the absence of both the President and the Secretary, a meeting may be convened on the requisition of three Trustees with the permission of the Board and the meeting shall be presided over by any one of the trustee decided among themselves.

f) The meetings shall be held at the office of the Trust Board or any convenient place.

g) Notice of an ordinary meeting, with a copy of the agenda, shall be sent by the Secretary to the Trustees at least seven days before the date fixed for the meeting.

h) The notice of the meeting may be served personally on the individual Trustees, and if it is not possible, be sent by Registered Post or Courier with acknowledgement, and such notice shall be deemed to be sufficient notice.

i) In case of any emergency, the Secretary or, in his absence or refusal, the President may convene a Special Meeting by giving 24-hour notice to the Trustees. Notice of such Special Meeting shall be served on the Trustees either personally or on any member of their family or on electronic mode.

j) The President or the Secretary shall convene a special or urgent meeting or on its own motion or on the requisition in writing by three or more Trustees specifying the purpose of the meeting and giving notice to the other Trustees.

k) Any member can give notice of a agenda to be moved at the meeting, which shall be delivered to the Secretary at least 5 days prior to the date of the meeting and upon such delivery, the same shall be circulated to the other members at least one day prior to the date of the meeting.

l) Any other issues may be placed by the secretary or President as table agenda in the Trust Board Meeting.

m) Any other issues may be placed as table agenda by the trustee giving copies to other trustees and such agenda may be considered by the Board of trustees in the same meeting or adjourned to next meeting or reject the issue by majority of voting.

n) All papers relating to the agenda shall be made available to the Trustees for inspection at the place of meeting at the time or before the commencement of the meeting.

o) Three members of the Board shall form the minimum Quorum necessary for a meeting of the Board. No business shall be transacted at any meeting unless there is a Quorum.

p) Every meeting of the Board of Trustees shall be presided over by the President and, in his absence, by a Trustee chosen by the Trustees present at the meeting to preside over the meeting.

q) Any question or issue which may come up before any meeting shall be decided by a majority of the votes of the members present,

r) The Chairperson or the presiding Trustee shall maintain order and decorum at the meetings. The subjects on the agenda shall be taken for consideration in the order in which they appear in the Agenda, unless it is decided at the meeting that they be considered otherwise.

s) All major decisions shall be taken only in the meetings of the Board and shall not be taken by way of resolutions passed by circulation unless agreed to by all the members. Any such decision taken in circulation shall be placed in the next meeting for confirmation. The question of whether a particular decision is major or not shall be decided by the Chairperson.

t) Any matter of business of a urgent nature may be determined by circular resolution without a meeting of the trustees provided that it is agreed by 2/3rd majority of the trustees such business matters determined by circular shall be recorded at the next meeting of the board of trustees. In case of difference of option, such question shall be dealt with at the next meeting of the trustees.

u) The business of the Board of Trustees shall be as far as possible be dealt with, in the meeting of the Board of Trustees, and by circulation, only when it is inevitable. Any subject that is required to be discussed in the meeting shall not be disposed of by circulation. No subject shall be refused to be considered whether at meeting or in circulation by the Board.

v) Minutes of meeting shall be recorded and maintain by the Secretary of the trust.

w) The Board of Trustees shall maintain Minutes of the proceedings of each of the meetings by recording the same in a book kept for that purpose. It shall be signed by the Chairperson and the Trustees. The Minutes book shall be kept in the office of the Trust in the custody of the Secretary or the Chairperson

x) Any trustee remaining absent from three consecutive meetings shall cease to be a trustee unless, his absence is condoned by the Trust Board.

y) The place of meeting of the Board of Trustees shall be decided by the Board of Trustees.

CLAUSE (12) POWERS AND DUTIES OF THE BOARD OF TRUSTEES:

The Board of Trustees shall have the following powers and duties: -

(a) To frame Rules and Regulations, Bye-laws as may be necessary for implementing this Scheme and submit the same for approval of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board.

(b) To prepare a Budget of Expenditure relating to the management, accounts and for the efficient running of the Trust and maintenance of the properties belonging to the Trust.

(c) To issue such directions as may be necessary for the proper and efficient administration of the Trust and properties.

(d) To raise funds, if necessary, by receiving grants, donations, gifts to achieve the object of the trust.

(e) To enter into contracts and to execute documents for the development of the Trust, and such documents shall be executed by the President and another Trustee as may be nominated by the Board.

(f) It is the duty of the Board of Trustees to administer the Trust and its properties effectively, maintain proper accounts and see that the funds of the Trust are utilised for the objects and purposes for which the Founder created the Trust.

CLAUSE (13)

The Board of Trustees shall prepare a list of properties both movables and immovables, shares, outstanding stock, etc. belonging to the Trust.

CLAUSE (14)

It is the duty of the Board of Trustees to administer the Trust effectively, maintain proper accounts and see that the resources of the Trust are utilized for the objects and purposes for which the Trust was created.

CLAUSE (15) SECRETARY :

The Secretary shall be the Administrative Officer of the Trust and shall be under the control of the Board of Trustees. He shall be responsible for the custody of all the records of the Trust. He shall issue notice to convene the meeting of the Board as directed by the President and shall prepare the agenda minutes, etc. for the same.

CLAUSE (16)

The Board of Trustees is authorized to appoint a Legal Advisor, if necessary, on such terms and conditions as the Board of Trustees may decide.

CLAUSE (17) AUDIT :

The accounts of the Trust shall be audited every year by a Chartered Accountant with an experience of not less than 5 years, to be appointed by the Board of Trustees. The fees of the Auditor shall be fixed by the Board of Trustees and paid by the Board of Trustees from the Trust funds.

CLAUSE (18) ACCOUNTS:

The Board of Trustees shall keep regular accounts of all transactions relating to the trust. The Board of Trustees shall prepare and furnish to the Board a full and true statement of accounts of all the monies received or expended by the trustee on behalf of the trust during the period of twelve months ending on the thirty-first day of March and thereafter the same shall be submitted to the Board on or before thirtieth day of April.

CLAUSE (19) INVESTMENT OF FUNDS:

The funds of the Trust shall be invested only in the name of the Trust in the Nationalized Banks as decided by the Board of Trustees.

CLAUSE (20) OPERATION OF BANK ACCOUNT:

All the accounts in all the banks shall be operated and the cheques signed jointly by the President and Secretary. It is open to the President and the Secretary to delegate this power to any other Trustee or Trustees by an unanimous resolution.

CLAUSE (21) FOUNDER'S DAY:

The Board of Trustees shall make necessary arrangements to celebrate and commemorate the Founder's day. It is the duty of the Board of Trustees to see that the cherished desires and objects of the Founder are being fully carried out.

CLAUSE (22) APPOINTMENT OF ENGINEER :

The Board of Trustees if it finds necessary, shall hire a qualified Engineer with not less than Ten years of experience to be in charge of the buildings belonging to the Trust and to take steps for the maintenance of the buildings and advise the Board of Trustees in the construction of any new building to be come up in future. The fees of the Engineer shall be fixed by the Board of Trustees.

CLAUSE (23) APPOINTMENT OF ESTATE OFFICER :

a. The President of the Trust Board, in consultation with the Board of Trustees, shall appoint a person as Estate Officer who shall be a retired Government servant with a good service record, with his Salary to be fixed by the Board of Trustees.

b. The Estate Officer appointed shall administer and manage the Property of Trust to have regular inspection of the properties and be responsible for the Collection of rents from the Tenants and shall maintain the proper accounts of the Trust.

CLAUSE (24) NEW PROJECT:

No new project or programme shall be taken up, launched or carried out by the Board of Trustees without the prior sanction of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board.

CLAUSE (25) BUDGET

The Board of trustees shall prepare a budget for the next financial year showing the estimated receipts and expenditure in such form as may be specified. The Board of trustees shall submit such budget at least ninety days before the beginning of the financial year to the Board (Section 37 of the Act may be referred for further details).

The budgetary provisions shall, as far as possible, be adhered to, and no expenditure not provided for any particular purpose shall be allowed or sanctioned by the Board of Trustees except for reasons to be recorded by them in writing.

CLAUSE (26) INSPECTION OF PROPERTIES :

The Trustees shall periodically either individually or together inspect the properties of the Trust to enforce the effective management.

CLAUSE (27) MAINTENANCE OF REGISTERS;

The Board of Trustees shall authorize the Secretary to maintain the necessary Registers prescribed in the Act and submit all statutory returns to the Board and other authorities.

CLAUSE (28): CUSTODY OF DOCUMENTS :

The relevant documents with respect to movable and immovable properties and outstanding claims shall be in the custody of Secretary or any trustee who is authorized by Board of Trustees.

CLAUSE (29) SITTING FEES AND CONVEYANCE:

The Board of Trustees is authorized to fix its sittings fees, however subject to the approval by the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board.

The Trustees shall be entitled to be paid / reimbursement of the actual expenses incurred by them in attending to the affairs of the Trust.

CLAUSE (30) PRIOR SANCTION FROM THE BOARD:

The Board of Trustees shall obtain the prior sanction of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board for any gift, exchange, hypothecation, mortgage or lease of any immovable property of the trust.

CLAUSE (31) MODIFICATION OR AMENDMENT OF THE SCHEME:

The Board of Trustees are at liberty to approach by way of an application to the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board for any modification or amendment of the provisions of this Scheme.

CLAUSE (32) RIGHT TO SUE :

The Trust shall sue and be sued in the name of the Secretary of the Board of Trustees.

CLAUSE (33) LEGAL MATTERS:-

The trustees shall have power to take legal actions, file and defend any suits, complaints, applications etc. in any civil, criminal courts or before any authority or authorities in connection with the trust properties, administration and to take such other steps as may be necessary in that behalf and incur expenditure for the same from the trust funds.

CLAUSE (34) RECEIPT OF DONATIONS :

The Board of Trustees may receive donations to augment the source of income of the Trust with the permission of Board.

CLAUSE(35) DEEMED TO BE PUBLIC SERVANTS :

The Trustees shall be deemed to be public servants under section 84 of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments (Protection and Maintenance) Act, 2018.

CLAUSE(36) TO CARRYOUT DIRECTIONS OF THE BOARD :

The Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board may, from time to time, issue such directions to the Trust, as it may deem fit, for giving effect to the provisions of this Scheme and it shall be the duty of the Trust, to comply with such directions.

CLAUSE (37) POWER OF THE BOARD TO MODIFY THE SCHEME :

Any amendment to or modification of this Scheme can be effected only by the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board on its own motion or upon filing an appropriate petition with notice to all the Trustees.

The Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board may add, delete or modify the scheme, at any time, in case of necessity.

CLAUSE (38) REFERENCE TO THE BOARD FOR ANY INTERPRETATION:

In all cases in which it is found necessary to seek advice or directions or if any dispute arises about the interpretation or construction of any of the clauses or provisions of the scheme, the board of trustees shall be entitled to refer the matter to the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board whose decision shall be final and conclusive.

CLAUSE (39)

The Trustees, beneficiaries and persons interested in the Trust are at liberty to approach the Board by way of an application for any direction, clarification and implementation of the provisions of the scheme.

CLAUSE (40)

The trust and trustees are bound by the Act 44 of 2018, rules and Regulations of the Board. Any of the clauses contained in the scheme is inconsistent with any of the provisions of Act 44 of 2018, the relevant Rules or Regulations of the Board, the above Act, Rules and Regulations shall prevail over the scheme.
