AND WHEREAS, in addition to the immovable properties ad-interimly attached in the Government Order first read above, the immovable properties specified in the Schedule to this Order are alleged to have been procured by the said financial establishment from and out of the deposits collected from the depositors;

NOW, THEREFORE, in exercise of the powers conferred by section 3 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997), the Governor of Tamil Nadu, hereby, makes an ad-interim order attaching the immovable properties owned by the accused G.Thangam, S/o.A.Ganesan of the financial establishment

Messrs Sri Amman Enterprises, functioned at No.40/52, Keelakalnayakkan Street, Woraiyur, Trichy, as specified in the Schedule to this Order and transfers the control over the properties to the Competent Authority, namely, the Competent Authority/District Revenue Officer, Trichy District, appointed under the said Act.

2. The Competent Authority / District Revenue Officer, Trichy District, is requested to pursue further action in accordance with the procedure laid down in sub-sections (3) and (4) of section 4 of the said Act and also the formalities prescribed in the Tamil Nadu Protection

of Interests of Depositors (in Financial Establishments) Rules, 1997.

3. The Special Public Prosecutor, Special Court for the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997, Madurai is requested to render necessary assistance to the Competent Authority / District Revenue Officer, Trichy District in filing the application before the Special Court constituted under the said Act.
