No.II(2)/AHDFW/489/2026.—In exercise of the powers conferred by sub-section (1) of Section 6 of the Prevention and Control of Infectious and Contagious Diseases in Animals Act 2009 (Central Act 27 of 2009) read with clause-4.2 of National Action Plan for Control and Eradication of Glanders in India (Revised 2025) by the Department of Animal Husbandry and Dairying Ministry of Fisheries, Animal Husbandry and Dairying, Government of India, New Delhi, the Governor of Tamil Nadu hereby declares the 02 k.m radius from the area of Nadukuppam, Triplicane, Zone 9 of Greater Chennai Corporation, Chennai as controlled area in respect of outbreak of Glanders Disease, which is a scheduled disease declared under the said Act whereby the Equines are infected. Restriction have been imposed on the movement of equines, donkeys and mules in and out of the notified area as per National Action Plan for Control and Eradication of Glanders in India (Revised 2025).

[Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997) – Messrs Money Deal Trading Solutions, Namakkal District - Default in return of deposits by the financial establishment – Ad-interim order attaching an immovable property of the said financial establishment under section 3 of the said Act - Orders - Issued.]

WHEREAS, complaints have been received from a number of depositors that Messrs Money Deal Trading Solutions, Namakkal District a financial establishment, has defaulted the return of deposits made by the depositors after maturity;

AND WHEREAS, the Government are satisfied that the said financial establishment is not likely to return the deposits to the depositors and hence, the Government have to protect the interests of such depositors;

AND WHEREAS, in addition to the movable and immovable properties ad-interimly attached in Government Order first and second read above, the immovable property specified in the Schedule to this Order are alleged to have been procured by the said financial establishment from and out of the deposits collected from the depositors;

NOW, THEREFORE, in exercise of the powers conferred by section 3 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997), the Governor of Tamil Nadu, hereby, makes an ad-interim order attaching the immovable property owned by Tmt. Vasanthayee, Mother of accused No.11-R.Arumugam of the financial establishment Messrs Money Deal Trading Solutions, functioned at S.K.P.Building, No.101, 102, 103, First Floor, near Municipality Marriage Hall, Thuraiyur Main Road, Namakkal District, as specified in the Schedule to this Order and transfers the control over the property to the Competent Authority, namely, the Competent

Authority / District Revenue Officer, Namakkal District, appointed under the said Act.

2. The Competent Authority / District Revenue Officer, Namakkal District, is requested to pursue further action in accordance with the procedure laid down in sub-sections (3) and (4) of section 4 of the said Act and also the formalities prescribed in the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Rules, 1997.

3. The Special Public Prosecutor, Special Court for the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997, Coimbatore is requested to render necessary assistance to the Competent Authority / District Revenue Officer, Namakkal District in filing the application before the Special Court constituted under the said Act.
