This notification is made under Sub Section(1) of section 11 of Right to Fair Compensation and Transparency in Land Acquisition and Resettlement Act 2013 (Central Act 30 of 2013) to all whom it may concern.

A Plan of the land may be inspected by the Revenue Divisional Officer, Pattukkottai or by the authorised officials on any other working day during the working hours.

The Government may authorize the Revenue Divisional Officer, Pattukkottai and his staff to enter upon a survey land, take levels of and land, digging or bore in to the sub - soil and do all other acts required for the proper execution of their work as provided and specified in section 11(4) of the said Act.

Under sub-section (4) of section 11 the said Act, no person shall make any transaction or cause any transaction of land i.e., sale/purchase etc., or create any encumbrances on such land from the date of publication of this notification in the *Tamil Nadu Government Gazette* without prior approval of the Revenue Divisional Officer, Pattukkottai.

In exercise of the powers delegated by the Government of Tamil Nadu in G.O.Ms. No.419, Housing and Urban Development Department dated 1st June 1984 under Section 91 (1) of the Tamil Nadu Town and Country Planning Act, 1971 the Member-Secretary, Chennai Metropolitan Development Authority hereby makes the following variation under Sub-section (4) of Section 32 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) to the Second Master Plan for Chennai Metropolitan Area 2026, approved in G.O.(Ms) No.190 Housing & Urban Development (UD I) Department dated 02.09.2008, G.O.(Ms) No.191, Housing & Urban Development (UD I) Department dated 02.09.2008 and published as Notification in No.266 Part II-Section 2 of the *Tamil Nadu Government Gazette* dated the 2nd September 2008.
