No. SRO A-7/2026.—In exercise of the powers conferred by sub-section (1) of section 24 of the Tamil Nadu Prohibition of Online Gambling and Regulation of Online Games Act, 2022 (Tamil Nadu Act 9 of 2023), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Online Gaming Authority and Regulation of Online Games Rules, 2023:-

AMENDMENT

In the said Rules, in rule 3,

(1) for sub-rule (2), the following sub-rule shall be substituted, namely:-

“(2) The application for grant of certificate of registration shall be accompanied by a fee of Rs.10,000/- (Rupees Ten Thousand only) by way of demand draft or banker's cheque drawn in favour of the Secretary, Tamil Nadu Online Gaming Authority, Chennai or by online payment”.

(2) in sub-rule (4), after the proviso, the following proviso shall be added, namely:-

“Provided further that in cases where queries or clarifications have been raised by the Authority, the period of fifteen days prescribed for the grant of certificate of registration will commence from the date of receipt of the reply for such queries or clarifications.”

No. SRO A-8/2026.—In exercise of the powers conferred by section 15 of the Tamil Nadu Home Guard Act, 1963 (Tamil Nadu Act 3 of 1963), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Home Guard Rules, 1963:-

AMENDMENT

In the said Rules, in rule 6(A), for the second proviso, the following proviso shall be substituted, namely:-

“Provided further that in case of re-appointment or the extension of appointment, a member of Home Guard may continue as such until he attains the age of 60 years.”
