In exercise of the powers of conferred by Section 61 of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments (Protection and Maintenance) Act, 2018 (Tamil Nadu Act 44 of 2018) the Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board by publishes **the following Scheme framed by the Vanniyakula Kshatriya Public Charitable Trusts and Endowments board** vide its resolution dated 20.01.2026 passed in the 33rd Board meeting held on 20.01.2026 **for Thirumathi Padma Mannan Educational and Charitable Trust** which was created by Thiru Mannan @ Mangalamannan son of Thiru Pachaiyappa Gounder, vide the Deed of Thirumathi Padma Mannan Educational and Charitable Trust dated 26.02.1998 registered as doc. No. 75/1998 in the office of Joint Sub Registrar II Saidapet, South Chennai and Thiru Mannan @ Mangalamannan, in the capacity as Manager and Secretary of Thirumathi Padma Mannan Educational and Charitable Trust executed the Will dated 30.06.2000 registered as doc. No.41/2000 in the office of Sub Registrar, Sriperumbudur bequeathing all his properties to the above trust:

SCHEME FOR

THIRUMATHI PADMA MANNAN EDUCATIONAL AND CHARITABLE TRUST

The SCHEME is hereby framed by The Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board (hereinafter referred to as the Board) in pursuance of the power conferred under section 61 of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments (Protection and Maintenance) Act, 2018 (hereinafter referred to as the Act) for the management and the administration of the **Thirumathi Padma Mannan Educational and Charitable Trust** which was created by Thiru Mannan @ Mangalamannan son of Thiru Pachaiyappa Gounder, vide the Deed of Thirumathi Padma Mannan Educational and Charitable Trust dated 26.02.1998 registered as doc. No. 75/1998 in the office of Joint Sub Registrar II Saidapet, South Chennai.

Subsequently, Thiru Mannan @ Mangalamannan, in the capacity as Manager and Secretary of Thirumathi Padma Mannan Educational and Charitable Trust executed the Will dated 30.06.2000 registered as doc. No.41/2000 in the office of Sub Registrar, Sriperumbudur. He entrusted his properties to the above trust namely:

- i. The property measuring to an extent of Acre 0.14 cents comprised in survey no. 1228/1A and an extent of Acre 0.11 cents (82 cents out of 93 cents acquired by the government for the extension of the road) comprised in survey no. 1230/1 (patta No. 1671) situated at No.105, Sriperumbudur Village, Kancheepuram District and more fully described in the schedule hereunder.
- ii. The property measuring to an extent of Acre 0.11 cents comprised in Old Survey No.322, New S.No.322/14 (Patta No.824) situated at No.163, Thiruneermalai Village, Pallavaram Taluk, Sub Registration District of Pallavaram and Registration District of Chennai and more fully described in the schedule hereunder.
- iii. In future, if it is known that any other properties stands in the name of Thiru Mangala mannan @ M.K.Mannan or Thirumathi Padma Mannan or in the name of trust will be included in the schedule.
- iv. Deposits, depentures etc. stands in the name of the trust and all the amounts pending in the bank accounts or the amounts if any deposited in any Government account or pending in any Government department or private concern in the name of the trust or belongs to the trust.

The **Thirumathi Padma Mannan Educational and Charitable Trust** shall come into effect with the main objects morefully set out hereunder from this date onwards.

There shall be a Trust in the name and style of **Thirumathi Padma Mannan Educational and Charitable Trust** that shall manage the movable and immovable properties donated by Thiru Mangala Mannan and Thirumathi Padma Mannan and morefully described in the Schedule hereunder.

The registered office of the Trust shall be at its present place in the premises bearing No.50, Sangam Salai, Lakshmipuram, Chromepet, Chennai – 600 044.

Main Objects of the Scheme:

- a) To form a Trust in the name and style of **Thirumathi Padma Mannan Educational and Charitable Trust** for the welfare and upliftment of students and persons belonging to Vanniyakula Kshatriya Community and the general public.
- b) To establish, run and maintain the Institute of technology, Educational Institutions like schools, colleges of Arts and Science, Polytechnics, Colleges of Engineering and Technology, Medicine, Law and post graduate institutions in the various fields of education in Engineering, Medicine, Commerce, Arts and Science, etc., either in the name of Thiru Mannan @ Mangala Mannan or in the name of **Thirumathi Padma Mannan**, for the welfare and upliftment of the students belonging to Vanniyakula Kshatriya Community and downtrodden people.
- c) To establish institutions for Research and Development in the various fields of education.
- d) To establish training centres, Model production centres and Industrial Units to facilitate practical training to students of polytechnic or Engineering or Technical College and provide them adequate training in production, financial, personal, marketing and industrial management for providing entrepreneurs skill of the outgoing students so as to create necessary confidence in the Vanniyar youths for self-employment.
- e) To train the students belonging to Vanniyakula Kshatriya community for competitive exams like NEET, JEE, UPSC, TNPSC, SSC, banking exams, etc.
- f) To grant scholarships, stipends and render financial aid to the needy students belonging to Vanniyakula Kshatriya community.
- g) To construct Kalayana Mandapam/Commercial complex, etc. in the name of **Thirumathi Padma Mannan Educational & Charitable Trust** to raise the income of the trust so as to make it self-reliant.
- h) To provide hostel facilities to the deserving Vanniyar and downtrodden students and to provide financial assistance to the fit and deserving students.
- i) To acquire by purchase, gift or otherwise, lands, house-sites and buildings, to erect, build and construct or aid and assist in the erection, construction of houses, buildings for educational institutions and colleges, libraries, staff quarters, hostels and/or other type of buildings of construction whatsoever and to maintain or run them and if necessary to alter, demolish or reconstruct them or any portion or portions thereof as may from time to time found necessary or expedient.
- j) To provide shelters to the pilgrims at important pilgrims centres and to provide necessary assistance to those who are affected by natural calamities and to do other charities which the Trustee deems think fit.
- k) To accept donations, endowments, gifts, grants-in-aid and subscriptions for all or any of the purpose of the Trust on such terms.
- l) To purchase, acquire, held and manage, all or any movable and immovable properties acquired or purchased by the Trust.
- m) To collect such rent or charges or other money from occupants of hostels, buildings or rooms, staff quarters, shops or commercial complexes otherwise as may be deemed necessary at the rates to be fixed by the Trust from time to time.
- n) To collect, manage and disburse the funds raised or to be raised for all or any of the objects of the Trust.
- o) The excess of Income over the Expenditure should be expended with the prior sanction of the Board by the Trustees in the Establishment of further educational institutions, any scheme for providing livelihood and upliftment of persons belonging to Vanniyakula Kshatriya Community.
- p) And generally to do and cause to be done all such lawful things as are in accordance with the spirit and principles or the objects of the Trust or which are conducive to the attainment and pursuit of the aims and objects of the Trust for the benefit of the Vanniyakula Kshatriya community at large from time to time.

THE BOARD OF TRUSTEES**CLAUSE – (1) CONSTITUTION OF THE BOARD OF TRUSTEES:**

- i. There shall be five trustees and among them one shall be the President, one shall be the Secretary of the Trust and one shall be the Treasurer of the Trust elected by the Board of Trustees.
- ii. Among the five Trustees, one shall be either a retired IAS Officer or District or Sub-ordinate Judge, or from the profession of lawyer or doctor,
- iii. One shall be an Engineer.
- iv. One shall be an either serving or retired official of the State or Central Government or Public Sector Undertaking.
- v. One Eminent person having good reputation who has served the cause of the Vanniyakula Kshatriya Community.
- vi. One shall be a Woman who has served the cause of the Vanniyakula Kshatriya Community.

CLAUSE – (2) QUALIFICATION:-

No person shall be elected or appointed to hold office as Trustee unless:-

- i. He or she is an Indian.
- ii. He or she is a Hindu by religion and has faith in any Hindu mode of worship and religious practice.
- iii. He or she must belongs to Vanniyakula Kshatriya Community.
- iv. He or she should have obtained a minimum educational qualification of SSLC from a School recognized by the Government.
- v. He or she should have completed 30 years of age.

CLAUSE – (3) DISQUALIFICATION: -

No person shall be elected or appointed or nominated to hold office as Trustee or to continue to hold Office.

- i. If he or she becomes a person of unsound mind.
- ii. If he or she is blind, deaf or mute.
- iii. If he or she is suffering from any serious mental disorder, leprosy or any contagious disease.
- iv. If he or she is an undischarged insolvent.
- v. If he or she is convicted of any criminal offence involving moral turpitude.
- vi. If he or she is removed from any other Trust /Charity/Charitable Society for any irregularity in the past.
- vii. If he or she is incapable of holding such a post by virtue of an order of court.
- viii. If he or she holds any position in any political party.

CLAUSE – (4) SELECTION OF BOARD OF TRUSTEES;

- i. An Interim Committee shall be formed with an official serving in or a suitable person selected by the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board, who shall be the Secretary of the Interim Committee and two trustees of the Trust selected by the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board as members. If the trust is not functioning or the existing trustees are not willing or co-operating all the three members shall be appointed by the Board itself.
- ii. The Interim Committee shall invite applications for appointment of Trustees by making suitable advertisement in one leading Tamil Daily.

- iii. The trustees, who have been selected as members of the Interim committee, may also apply for the appointment of trustees.
- iv. The interim committee shall fix the last date for receipt of applications.
- v. The Interim committee shall fix a non-refundable fee of Rs. 500/- payable by each of the applicant who wishes to apply.
- vi. On receipt of the applications, the Interim committee shall scrutinize and process the same and place the application of those who have the necessary qualification as indicated in clause (2) before the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board at the earliest for selection and appointment of the Board of Trustees.

CLAUSE – (5) TENURE OF OFFICE: -

Every Trustee selected, appointed, or nominated under the scheme shall hold office for a period of three years. The persons selected, appointed or nominated as Trustee shall be eligible to be re-selected or re-appointed or re-nominated for another period of three years. But, no Trustee shall serve more than two periods consecutively.

CLAUSE (6)

The future vacancies arising in the Board of Trustees caused by death, resignation, retirement, disqualification or by efflux of time shall be filled up from the rest of the qualified applicants who had already applied in Clause (4) if available and willing. Otherwise, the future vacancies will be filled up as per clause 4 of the scheme by inviting applications for appointment of Trustees by making suitable advertisement in one leading Tamil Daily for the remaining period of his/their tenure.

CLAUSE (7)

The person appointed as Trustee shall furnish a security deposit of Rs. 2000/- (Rupees Two Thousand) only by way of demand draft in the name of the Trust which shall be refundable to the person concerned on their retirement without interest.

CONVENING OF BOARD MEETING

CLAUSE (8)

The Board of Trustees shall meet and transact business at least once in a month and if necessary, more often. The quorum for the conduct of the business shall be not less than three Trustees. The resolution of the Board shall be decided by the majority of the Board of Trustees present and voting. The meeting of the Board shall also be convened by the Secretary with the direction of the President on the requisition received from a Trustee, after giving due notice of not less than one week to the Trustees.

CLAUSE (9)

The place of meeting of the Board of Trustees shall be decided by the Board of Trustees.

CLAUSE (10)

A Trustee, who is absent without any reasonable cause for three consecutive meetings of the Board of Trustees, shall cease to be a Trustee.

ADMINISTRATION AND MANAGEMENT

CLAUSE (11)

The Board of Trustees shall frame Bye-laws and submit the same for approval of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board. The Board of Trustees shall prepare a list of properties both movables and immovables, shares, outstanding stock, etc. belonging to the Trust.

CLAUSE (12)

It is the duty of the Board of Trustees to administer the Trust effectively, maintain proper accounts and see that the resources of the Trust are utilized for the objects and purposes for which the Trust was created.

CLAUSE (13)

The Secretary shall be the Administrative Officer of the Trust and shall be under the control of the Board of Trustees. He shall be responsible for the custody of all the records of the Trust. He shall issue notice to convene the meeting of the Board as directed by the President and shall prepare the agenda minutes, etc. for the same.

CLAUSE (14)

The Board of Trustees is authorized to appoint a Legal Advisor, if necessary, on such terms and conditions as the Board of Trustees may decide.

CLAUSE (15)

The accounts of the Trust shall be audited every year by a Chartered Accountant with an experience of not less than 5 years, to be appointed by the Board of Trustees. The fees of the Auditor shall be fixed by the Board of Trustees.

CLAUSE (16)

The Board of Trustees shall keep regular accounts of all transactions relating to the trust. The Board of Trustees shall prepare and furnish to the Board a full and true statement of accounts of all the monies received or expended by the trustee on behalf of the trust during the period of twelve months ending on the thirty-first day of March and thereafter the same shall be submitted to the Board on or before thirtieth day of April.

CLAUSE (17)

The funds of the Trust shall be invested only in the name of the Trust in the Nationalized Banks as decided by the Board of Trustees.

CLAUSE (18)

The Bank accounts shall be operated jointly by the secretary and one of the trustees duly authorised by the Board of Trustees.

CLAUSE (19)

The Board of Trustees shall make necessary arrangements to celebrate and commemorate the Founder's day.

CLAUSE (20)

The Board of Trustees if it finds necessary, shall hire a qualified Engineer with not less than five years of experience to be in charge of the buildings belonging to the Trust and to take steps for the maintenance of the buildings and advise the Board of Trustees in the construction of any new building to be made in future. The fees of the Engineer shall be fixed by the Board of Trustees.

CLAUSE (21)

It is the duty of the Board of Trustees to see that the cherished desires and objects of the Founder are being fully carried out.

CLAUSE (22)

The business of the Board of Trustees shall be as far as possible be dealt with, in the meeting of the Board of Trustees, and by circulation, only when it is inevitable. Any subject that is required to be discussed in the meeting shall not be disposed of by circulation. No subject shall be refused to be considered whether at meeting or in circulation by the Board.

CLAUSE (23)

No new project or programme shall be taken up, launched or carried out by the Board of Trustees without the prior sanction of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board.

CLAUSE (24)

The Board of trustees shall prepare a budget for the next financial year showing the estimated receipts and expenditure in such form as may be specified. The Board of trustees shall submit such budget at least ninety days before the beginning of the financial year to the Board (Section 37 of the Act may be referred for further details).

CLAUSE (25)

The Trustees shall periodically either individually or together inspect the properties of the Trust to enforce the effective management.

CLAUSE (26)

The Board of Trustees shall authorize the Secretary to maintain the necessary Registers prescribed in the Act.

CLAUSE (27)

The Board of Trustees is authorized to fix its sittings fees, however subject to the approval by the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board.

CLAUSE (28)

The Board of Trustees shall obtain the prior sanction of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board for any gift, sale, exchange, hypothecation, mortgage or lease of any immovable property of the trust.

CLAUSE (29):

The relevant documents with respect to movable and immovable properties and outstanding claims shall be in the custody of Board of Trustees.

CLAUSE (30)

The Board of Trustees are at liberty to approach by way of an application to the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board for any modification of the provisions of this Scheme.

CLAUSE (31)

The Trust shall sue and be sued in the name of the Secretary of the Board of Trustees.

CLAUSE (32)

The Board of Trustees may receive donations to augment the source of income of the Trust with the permission of Board.

CLAUSE (33)

Any deviant behavior of any Trustee shall immediately be brought to the knowledge of Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board for appropriate action as decided by the Board.

CLAUSE(34)

The Trustees shall be deemed to be public servants under section section 84 of the Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments (Protection and Maintenance) Act, 2018

CLAUSE(35)

The Trustees shall be liable for acts of malfeasance, misfeasance and non-feasance.

CLAUSE(36)

The Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board may, from time to time, issue such directions to the Trust, as it may deem fit, for giving effect to the provisions of this Scheme and it shall be the duty of the Trust, to comply with such directions.

CLAUSE (37)

The Tamil Nadu Vanniyakula Kshatriya Public Charitable Trusts and Endowments Board may add, delete or modify the scheme, at any time, in case of necessity.

CLAUSE (38)

The trust and trustees are bound by the Act 44 of 2018, rules and Regulations of the Board. Any of the clauses contained in the scheme is inconsistent with any of the provisions of Act 44 of 2018, the relevant Rules or Regulations of the Board, the above Act, Rules and Regulations shall prevail over the scheme.
